Conditions:

1. The school is registered under the Child Rights Education Act, 2009, and the Karnataka Education Act, 1985 and the rules framed thereunder, and the accreditation is renewed up to the registered class. Apart from these classes, additional classes and extra sections are not permitted.
2. The school is governed by the Karnataka Education Act 1983 and the Child Rights Education Act 2009 under the rules framed thereunder.
3. Child Rights Education Act 2009 to reserve 2516% seats for weaker section children as per rules framed thereunder. The government has the authority to register the reserved seats under RTE for the schools covered by RTE. (Government has made rules to facilitate the enrollment of children in neighboring schools where their parents live, according to which, if there are government and government-funded educational institutions, children will be enrolled in that school) Otherwise, private schools will enroll children enrolled by the government and allow them to continue their education up to the primary level. To enable these children to continue their education without any discrimination,
4. Fees of children enrolled under RTE rules as described in Annexure 2 will be released by the Government as per rules. Hence it has stopped charging any fees from these children.

5. The school and the school management are prohibited from collecting any cleared capitation fee and voluntary donations from the parents in any manner either at the time of enrollment or thereafter.
6. The school/governing body shall publish the information on the fees collected from the parents of the children in their school as tuition fee vide State Government Notification No. ED.31: VGC:2019, dated: 27.07.2019 on the departmental website and on the school notice board. No additional fee shall be charged for the fixed fee.
7. The Management Board shall debrief the students within the period fixed by the Government.
8. The School Governing Body cannot refuse enrollment against the following factors.
 - (i) Due to lack of proof of age.
 - (ii) On the basis of caste, religion, place of birth, language.
 - (iii) If admission is sought after the grace period of admission.
9. Carrying out all safety measures as per RTE Act and Rules, Karnataka Education Act and Rules. [Fire safety and building safety certificate from concerned authorities and child learning safety as per K.S.C.P.CR and N.C.P.C.R).
10. The School / Governing Body is as follows
 - (i) No child who has received an area shall be retained in any class or expelled from school until he completes primary education and secondary education in school.
 - (ii) No child shall be subjected to physical or mental abuse.
 - (iii) No child shall be required to pass any board examination till completion of primary education.
 - (iv) Every child who completes primary education is issued a certificate as prescribed under Rule 21 of RTE and the Karnataka Education Act and Rules.
 - (v) As per the provisions of the RTE Act and Rules and the Karnataka Education Act and Rules the school shall also admit children with special needs / special children.
 - (vi) Appointed teachers shall possess the minimum qualifications as prescribed for primary and high school teachers in the RTE Act and Rules and the Karnataka Education Act and Rules and Government Orders.
 - (vii) Salary and allowances payable to teachers and terms and conditions of service shall be as prescribed by the State Government. And salary is paid to teachers through government notification (Bhavishya Nidhi (P)) and payable bank and other salaries and subject to Employee State Insurance (ESI).
 - (viii) Teachers shall perform the duties prescribed under Section 24(1) of the Act and the RTE Act and Rules as well as Rule 17 of the Karnataka Education Act and Rules and shall not involve themselves in private tupans for supervisory considerations.
11. Following the academic state curriculum and state text books to which the school is affiliated.
12. the school shall maintain the norms and standards as specified in Section 19 of the Karnataka Education Act. and appointing departmental staff as prescribed in the rules.
13. School buildings and other basic facilities associated with the school should not be given over to any commercial activities or political and non-educational activities during the day or night.
14. The school shall not be run for the benefit of any person or group or association.

15. Get the school audited by a Chartered Accountant. Copy to Deputy Director/ Field Education Officer by end of June every year
16. The school shall follow the language policy as per the Government Notification (Kannada Language Policy 2016).
17. Governing body and teachers to act as per RTE Act and Karnataka Education Act and Rules.
18. The school / governing body shall strictly follow the rules and directives of the Government and the Department.
19. Mandatory regular updating of school information in S.A.T.S. by the end of March every year.
20. In case of violation of the above conditions, the recognition of the school will be canceled as per the rules framed under RTE Act 2009 and Karnataka Education Act 1983.
21. After the school accreditation process is completed, the entire document information in the application submitted online by the governing body will be made available for public viewing on the departmental website.
